Call to Order Routine

Business:

Approval of consent agenda containing prior month's minutes of regular and/or special meetings (September 9th,2025), expense vouchers and Treasurer's report(September 2025). Reports: Strike copier from agenda; add appointing planning members; Daniels motioned, Schilling seconded; Motion passed

- 1. Fire/ EMS; No pressing issues
- 2. Custodian: An oak Tree at the back waters was blocking ¾ of entrance, that has been removed; Front door at community center has been being "propped" open during events, this could cause damages to door, there is a button that can engage the "hold door" function; Jason will inform Management Council
 - 3. Transfer Station; short on key at transfer station due to being short on staff; Tim got a key box to hold keys to avoid further issues; Talked to Jack(heater guy) about heaters for the shed at the transfer station; Tim gave the board an amazon option for a heater that would work best; heater shown has timer to avoid incident.; Talked about moving the shed from the beach to transfer station to replace old shed

- 4. Management Council: Craft show this weekend(fall/Christmas), Baby showers this month along with a wedding at the end.
